## PSC Announces Customer Public Hearings in Dominion Energy South Carolina, Inc. Case (Docket No. 2024-34-E)

Columbia, South Carolina—The Public Service Commission has scheduled four customer public hearings in [Docket No. 2024-34-E](#), involving Dominion Energy South Carolina, Inc. (“the Company”)’s application for authority to adjust and increase its retail electric rate schedules, tariffs, and terms and conditions. This filing includes a request for an increase to retail electric rates, and the Company’s application can be reviewed [at this link](#).

These customer public hearings will be held in four locations across the state over four days (with a fifth date if needed to include all customers who preregister). The schedule follows:

In its application, the Company proposes an increase of \$18.86 or 14.21% for residential customers, an increase of \$2,002.25 or 12.32% for commercial customers, and an increase of \$57,486.40 or 12.68% for industrial customers. In hosting these customer public hearings, the PSC seeks to hear from Dominion Energy South Carolina customers on the Company’s proposed new rates and their experiences with DESC as ratepayers.
