## PUBLIC NOTICE

**Subject: RE: Dual Party Relay charge**  
**Effective Date: January 1, 2017**

All Commercial Mobile Radio Services CMRS (wireless) and VoIP providers must begin collecting a Dual Party Relay charge and remitting the collected funds to the South Carolina Department of Revenue (DOR). The full implementation date is **January 1, 2017**.

**Commercial Mobile Radio Services providers (CMRS):** S.C. Code Section 58-9-2535 (B). A CMRS provider must collect the Dual Party Relay charge for each CMRS connection for which there is a mobile identification number containing an area code assigned to this state by the North American Numbering Plan Administrator. The collected Dual Party Relay charges must be remitted to the DOR (less a 2% administrative fee that may be retained by the provider). Effective January 1, 2017, the Dual Party Relay charge per CMRS connection is \$ 0.06.

**Prepaid Wireless Sellers:** S.C. Code Section 58-9-2535(D). Effective January 1, 2017, the Dual Party Relay charge per retail transaction is \$ 0.06. The collected dual party relay charges must be remitted to the DOR (less a 3% administrative fee that may be retained by the prepaid wireless seller). The prepaid wireless seller shall complete DOR Form ST-406.

**VoIP providers:** S.C. Code Section 58-9-2535 (C). A VoIP provider must collect the Dual Party Relay charge on each South Carolina VoIP service line. The collected Dual Party Relay charges will be remitted to the DOR (less a 2% administrative fee that may be retained by the provider). Effective January 1, 2017, the Dual Party Relay charge per line is \$ 0.06.

To implement this law, the South Carolina Office of Regulatory Staff (ORS), the designated administrator of the Dual Party Relay Fund in South Carolina, requires that each CMRS and VoIP provider register with the ORS.

**Telephone utilities** shall continue to remit Dual Party Relay charges to the ORS (less a 2% administrative fee that may be retained by the telephone utility). Effective January 1, 2017, the Dual Party Relay charge per line is \$0.06.
