Order Adding Requirements for Allowable Ex Parte Communication Briefings

SUBJECT:

Docket No. 2005-83-A - Public Service Commission of South Carolina - Administrative and Procedural Matters - Staff Presents for Commission Consideration Procedural Issues Related to Requests for Allowable Ex Parte Briefings.

COMMISSION ACTION:

With regard to the procedures for an allowable ex parte communication briefing pursuant to SC Code Ann. Section 58-3-260(C)(6), I move that the Commission require any person, entity, or party requesting an allowable ex parte communication briefing must communicate with the Clerk’s Office in writing to request an available date on the Commission’s calendar for the proposed allowable ex parte communication briefing. The written communication seeking a date for an allowable ex parte briefing must be made prior to filing a written Notice of Request for Allowable Ex Parte Communication Briefing with the Commission and must be sent to the Office of Regulatory Staff and all parties, in cases where there is a pending docket. The Commission Staff will respond in writing regarding the availability of any proposed or possible dates.

The Commission Staff is instructed to reject any Notice of Request for Allowable Ex Parte Communication Briefing where a requestor has not requested a date from the Clerk’s Office in writing.

I further move this Order must be posted on the Commission’s website under the Allowable Ex Parte Communications Briefings tab. Further, I request respectfully that the Office of Regulatory Staff place a copy of this Order on the ORS website with the other materials related to Allowable Ex Parte Communication Briefings.
