## PSC Elects New Officers

Inducts New Commissioner.

In July, the Public Service Commission elected a new Chairman and Vice-Chairman. The Commission also welcomed a new Commissioner, Elliott F. Elam, Jr.

The Public Service Commission has elected new officers. Nikiya "Nikki" Hall (6<sup>th</sup> District) was named Chairman and Swain E. Whitfield (5th District) was named Vice Chairman. In addition to her Commission duties in South Carolina, Chairman Hall is a member of the National Association of Regulatory Utility Commissioners (NARUC), where she serves as Chairman of the Utility Market Access Subcommittee, and a member of the Washington Action Program and Committee on Energy Resources and the Environment

As Vice Chair, Commissioner Whitfield will assist the Chairman with the continued advancement of its procedures, regulations, and rulings. Commissioner Whitfield is an active member of NARUC, serving as Co-Vice Chair of its Committee on Critical Infrastructure, and serving as a member on three other NARUC committees. ## Appointment to GTI Advisory Committee

Vice Chairman Swain E. Whitfield was recently appointed as Vice Chairman of the Gas Technology Institute's Public Interest Advisory Committee. The following article details his role and the mission of the Committee.



Congratulations to Vice Chairman Swain E. Whitfield on his recent appointment to Vice Chairman of the Gas Technology Institute's (GTI) Public Interest Advisory Committee (PIAC)! GTI is a research, development, and training organization that addresses energy and environmental challenges to enable a secure, abundant, and affordable energy future. The PIAC provides public and gas consumer interest guidance to the GTI and its Board. The Committee is made up of public utility commissioners, consumer advocates, and environmental, economic, and university-based experts.

Vice Chairman Whitfield said of his appointment, "Serving on the GTI PIAC is one of the most interesting things I have done since becoming a Commissioner. It is critical that we have quality research and development in the natural gas industry. Natural gas is a clean, abundant, domestic ener-

gy source and continuing to advance new technologies in natural gas is crucial to our nation. While South Carolina does not produce natural gas, GTI's focus does impact ratepayers in South Carolina, including, but not limited to: pipeline distribution safety and integrity, combined heat and power distribution generation, and gas-electric interoperability. I am very fortunate to be associated with GTI, along with a few members from the NARUC Committee on Gas. and very honored to be elected Vice Chairman by my colleagues."

# Cyber Security Presentation

In August, the PSC hosted two presenters from the South Carolina Budget and Control Board (B&CB), Division of Information Security (DIS), and the Enterprise Privacy Office (EPO), to discuss Cyber Security Awareness and Information Security.



The PSC hosted Sarah Marrow, Chief Privacy Officer of the EPO, and Marcos Vieyra, Chief Information Security Officer of DIS, in August to discuss the increased importance of Cyber Security Awareness and Information Security. The presenters stressed that "anything that is connected to the Internet is accessible by anyone that is on the Internet." This concept is concerning due to the reality that everything today from point -of-sale systems to power grids are connected to the Internet. The presentation emphasized that even with recent improvements to security and privacy efforts, we will always live with a certain amount of risk.

People, processes, and technology are the most important fac-

tors in alleviating the risks associated with cyber security and information security. The implementation of technology can make the environment safer to enable us to be better stewards and guardians of information. Processes can be aided by policy and practice guidelines; however, "people" is the most important factor. People have to utilize the technology available to them and must be aware of the policy guidelines. Ultimately, people will have the largest impact on cyber security and information security efforts.

## DMS Update

In October, the PSC's Docket Management System (DMS) was updated to differentiate between a Commission Directive and a Hearing Officer or Hearing Examiner Directive. A Commission Directive is issued during a Commission Meeting, while a Hearing Officer or Hearing Examiner Directive is issued by the attorney assigned to that matter. The Directives issued by a Hearing Officer or Examiner that stand as an Order are assigned an order number with an "H". The update will allow the Commission to efficiently serve all of its decisions/orders and to collect accurate data. The screenshot below details the DMS update.
