PSC Hosts Customer Public Hearing to Gather Testimony from Duke Energy Carolinas/Duke Energy Progress Ratepayers in September 2024

Columbia, S.C.—The Public Service Commission has rescheduled a customer public hearing in Docket Nos. [2023-8-E](#) and [2023-10-E](#), two Commission Dockets that involve Duke Energy Progress, LLC and Duke Energy Carolinas, LLC’s 2023 Integrated Resource Plan (IRP). The customer public hearing will take place at 10 a.m. on Monday, September 9th and will continue at 5:30 p.m. on September 9th (with an option to continue on Tuesday, September 10th if and only if all pre-registration slots for September 9th are filled). Customers can testify either at the Commission’s office (101 Executive Center Drive, Columbia, SC 29210) or virtually.

The purpose of this hearing is to hear testimony from the Companies’ customer base and their opinions on Duke Energy Carolinas and Duke Energy Progress’s Integrated Resource Plan. An Integrated Resource Plan is an electric utility’s forecast or prediction of the electric utility’s resources needed to provide you with safe, reliable electricity in the future. Essentially, it is a utility’s strategic operational plan for the next 15 years that considers both customers’ demand for electricity and the utility’s ability to supply it.
